RAFFLE RULES AND INFORMATION

1. The Chandler Service Club raffle prize #1 will be a custom white gold Kunzite and diamond necklace, featuring a triple AAA quality Kunzite stone at approximately 15 carats topped with a .20 single diamond. valued at \$4,850 from Christopher and Myranda Fine Diamonds.
2. The Chandler Service Club raffle prize #2 will be a \$1000 Gift Certificate to Christopher & Myranda Fine Diamonds
3. The Chandler Service Club raffle prize #3 will be a \$500 Gift Certificate to Christopher and Myranda Fine Diamonds.
4. The Chandler Service Club "Pretty in Pink" Raffle drawing will be held on February 23, 2019. The purchaser of the winning tickets need not be present to win.
5. The purchase price of 1 raffle ticket is \$50.00. Please note that the IRS has taken the position that amounts paid for chances to participate in a raffle do not qualify as a tax deductible charitable contribution.
6. Payment will be accepted in the form of credit card, cash or check. All payments made by check should be made payable to Chandler Service Club. Upon receipt of payment, ticket(s) will be mailed within 15 working days, if not given directly to the entrant. Dishonored checks or credit cards will render the raffle ticket invalid unless full payment is made prior to the drawing. Entrant will be notified by phone or email if payment is dishonored.
7. Raffle tickets may be purchased via the internet through the Chandler Service Club website at www.chandlerclub.org. The purchaser will automatically receive a confirmation of the raffle ticket purchase. If confirmation is not received, the purchase was not received by the CSC. Upon receipt of the raffle ticket purchase, CSC will fill out the purchaser's name, address and phone number on the raffle ticket stub and mail the ticket to the purchaser. The stub will be placed in the bin with all other "sold" raffle tickets.
8. All ticket purchases are final and nonrefundable.
9. No more than 350 tickets will be sold. Any ticket forms and money turned in after closure of the raffle will be returned to the buyer. Any checks or purchases received after the 350 tickets are sold will be rejected and returned to the buyer.
10. One name only can be associated with each raffle ticket. Delivery of the prizes will be made solely to the entrant. Winner will be contacted within 15 working days to arrange delivery of the prize.
11. Purchasers must be 21 years of age or older.
12. Chandler Service Club Board members and their spouses are not eligible to participate in or benefit from the raffle.
13. The Social Security number of the winner must be provided in order to claim possession of the prize.
14. Taxes and IRS Rules: Raffle winnings are taxable income to the winner and must be reported on income tax returns (please contact your tax advisor). The winner shall be responsible for all applicable state and federal income taxes at the time that tax returns are filed. The prizes will not be distributed until Chandler Service Club has received from the winner all signed documentation as may be required by the organization to fulfill its income reporting obligations. Federal and state tax withholding laws are subject to change without notice. The withholding laws in effect at the time the prize is distributed will be followed.
15. Name of the winner will be available to the media and the Chandler Service Club website and/or social media sites. Purchase of a raffle ticket constitutes permission for Chandler Service Club to use the winner's name and/or likeness in perpetuity, for purposes of advertising the raffle or future raffles without further consent or compensation, unless prohibited by law.
16. Diamond Necklace may not be exchanged or redeemed for cash. Additionally, any prize exchange or substitution will be conducted after all raffle matters are concluded, including tax withholding and reporting, between the winner and the original donor. Chandler Service Club will not participate, coordinate or facilitate any exchange or substitution request of the winner.
17. The decision of Chandler Service Club shall be final on all matters concerning the raffle.
18. The purchase of tickets for this raffle is void where prohibited by law.
